Planar passivated high commutation three quadrant triac in a SOT186A (TO-220F) "full pack" plastic package. The "series D" triac balances the requirements of commutation performance and gate sensitivity. 


Fig. 1. RMS on-state current as a function of surge duration; maximum values




Fig. 2. RMS on-state current as a function of heatsink temperature; maximum values




Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values






Fig. 4. Non-repetitive peak on-state current as a function of pulse width; maximum values






Fig. 8. Normalized latching current as a function of junction temperature


Fig. 10. On-state current as a function of on-state voltage

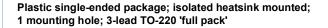




