## 1. Product profile

### 1.1 General description

Planar passivated high commutation three quadrant triac in a SOT78 (TO-220AB) plastic package intended for use in circuits where high static and dynamic  $dV/dt$  and high  $dI/dt$  can occur. This "series B0" triac will commute the full RMS current at the maximum rated junction temperature without the aid of a snubber.

- High immunity to false turn-on by  $dV/dt$
- High minimum  $I_{GT}$  for guaranteed immunity to gate noise
- High voltage capability



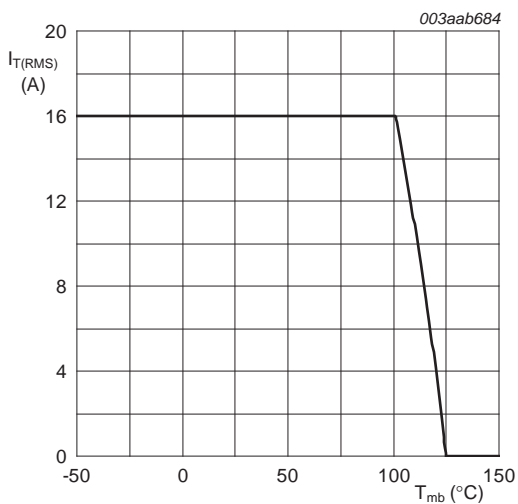

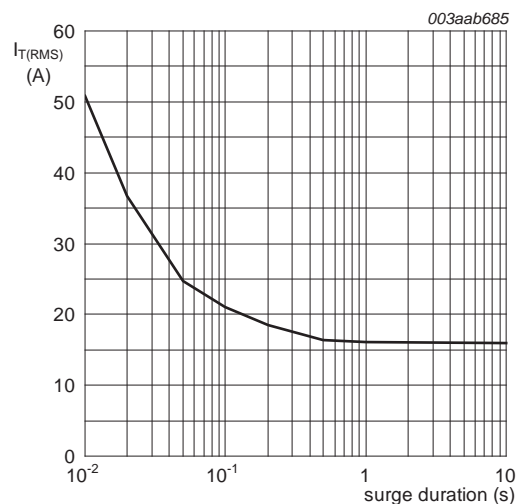

**Fig 2. RMS on-state current as a function of surge duration; maximum values**

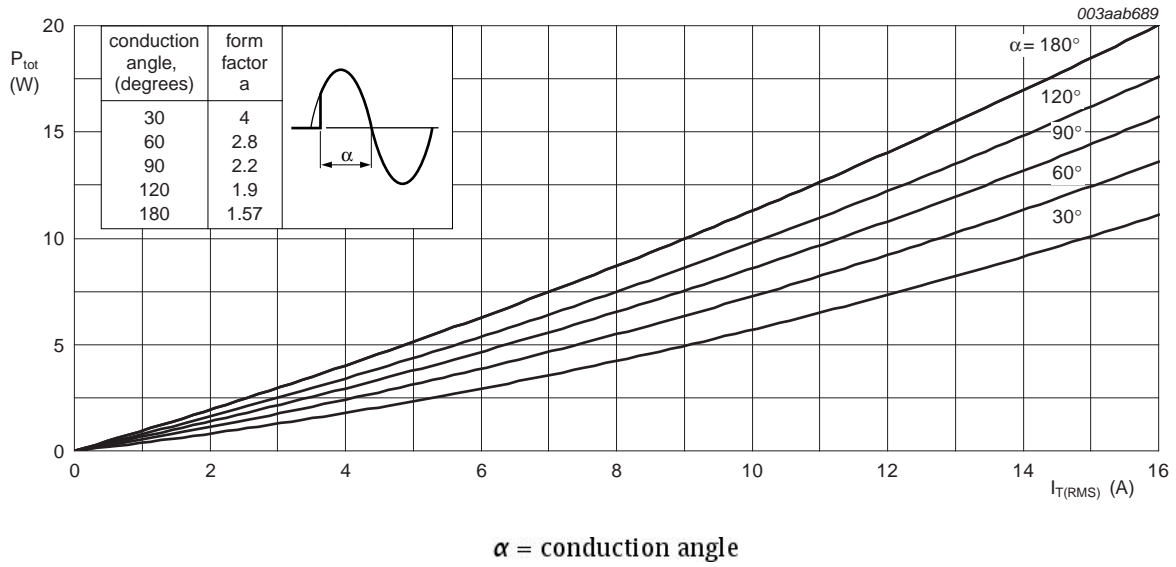


Fig 3. Total power dissipation as a function of RMS on-state current; maximum values

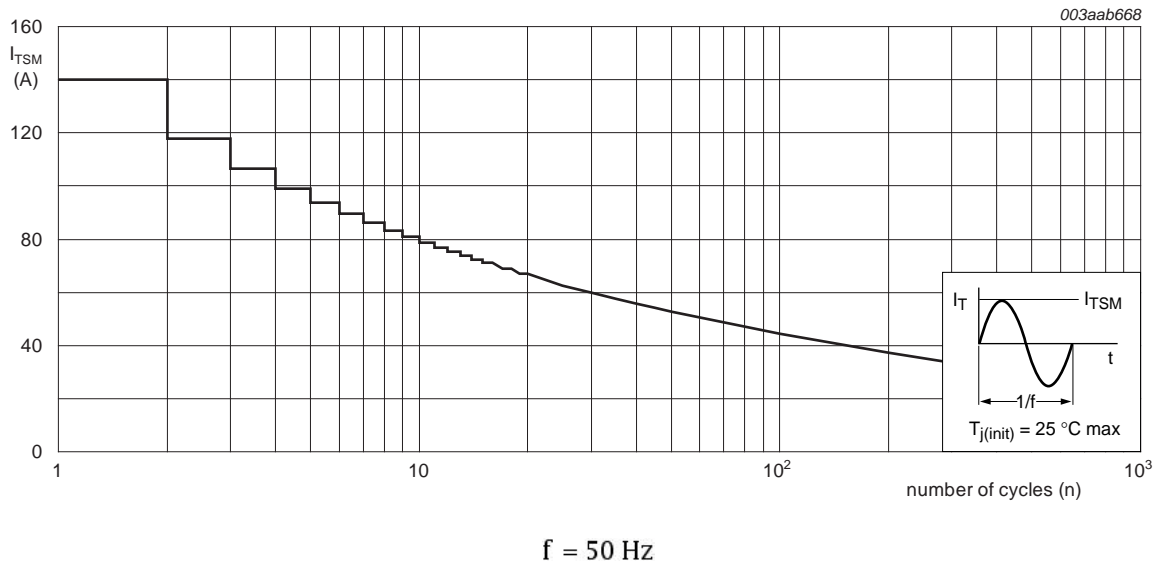


Fig 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values

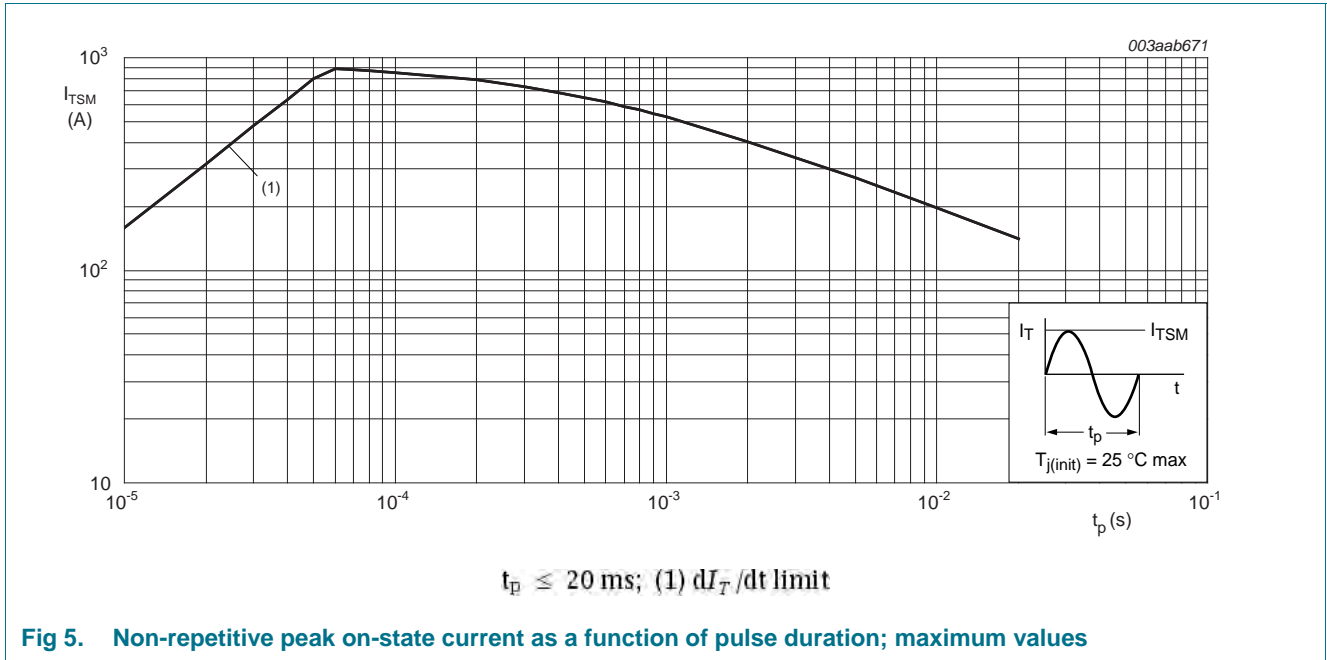


Fig 5. Non-repetitive peak on-state current as a function of pulse duration; maximum values

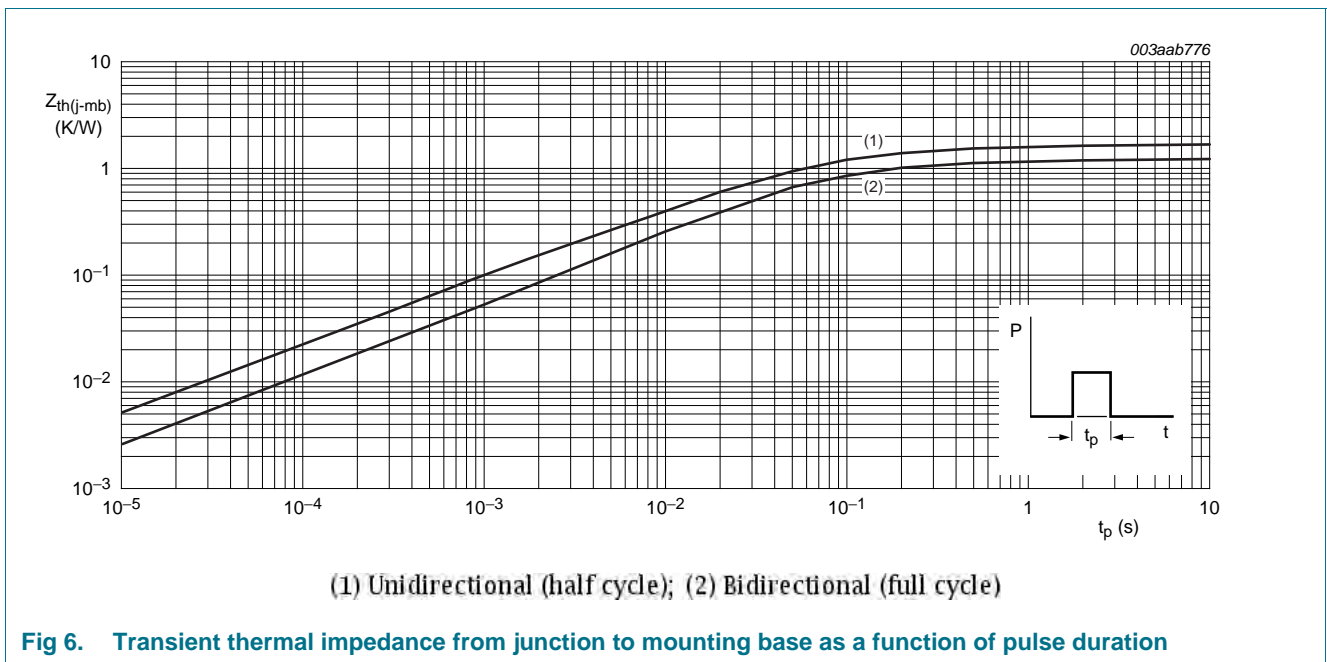
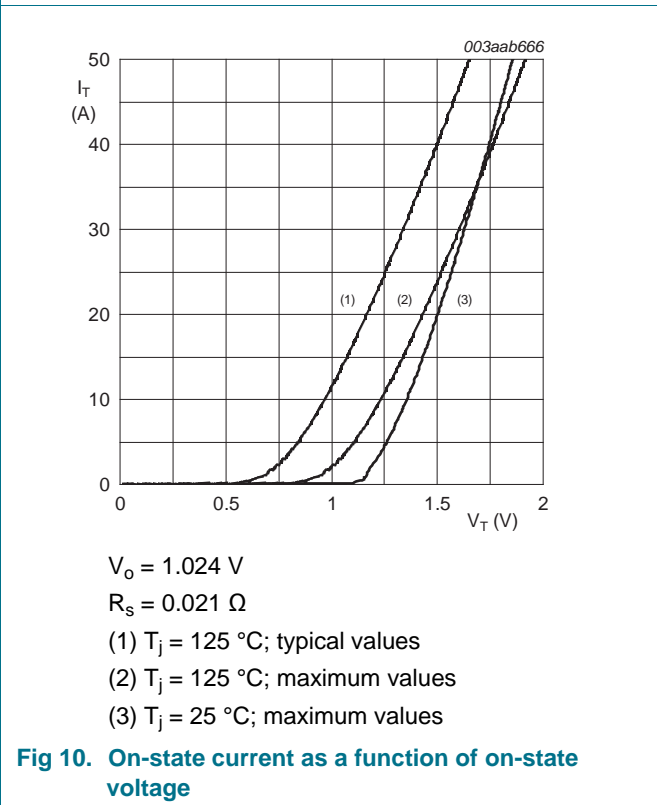
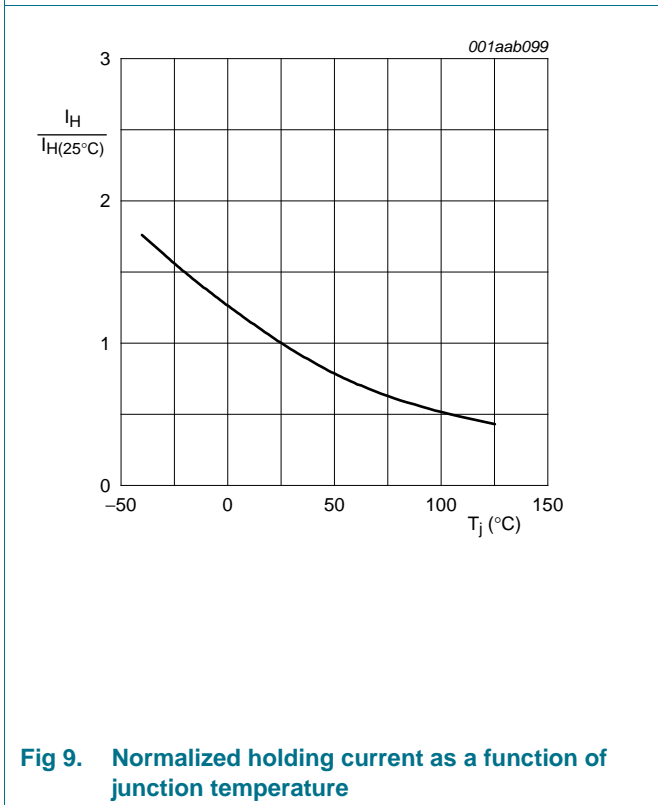
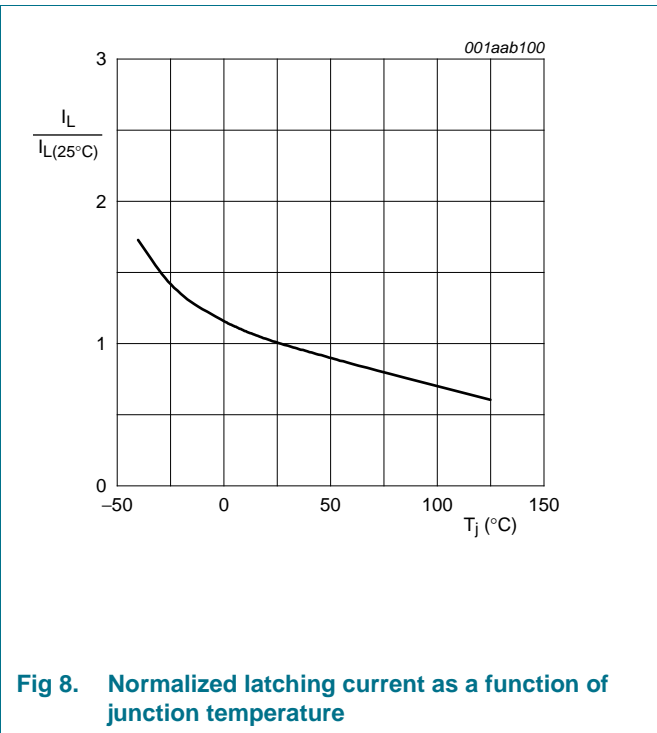
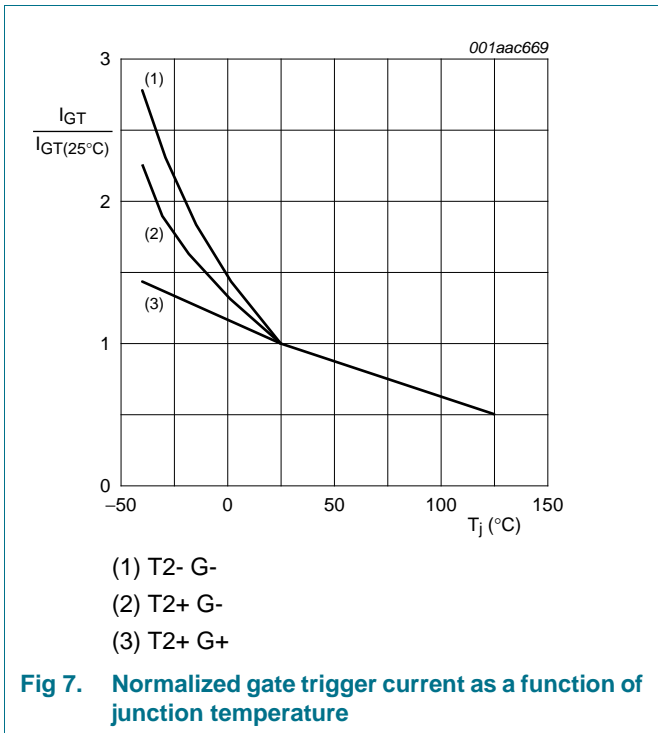


Fig 6. Transient thermal impedance from junction to mounting base as a function of pulse duration

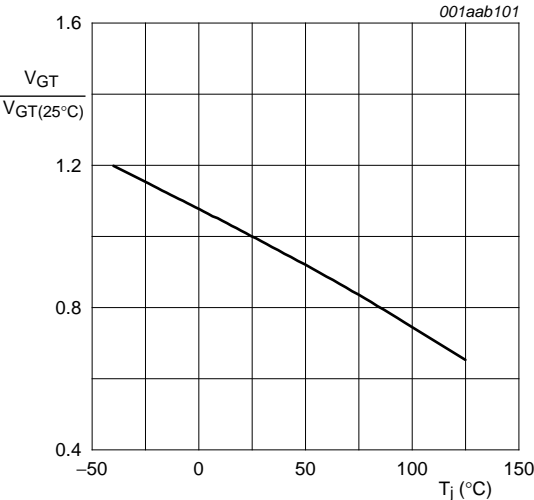


Fig 11. Normalized gate trigger voltage as a function of junction temperature

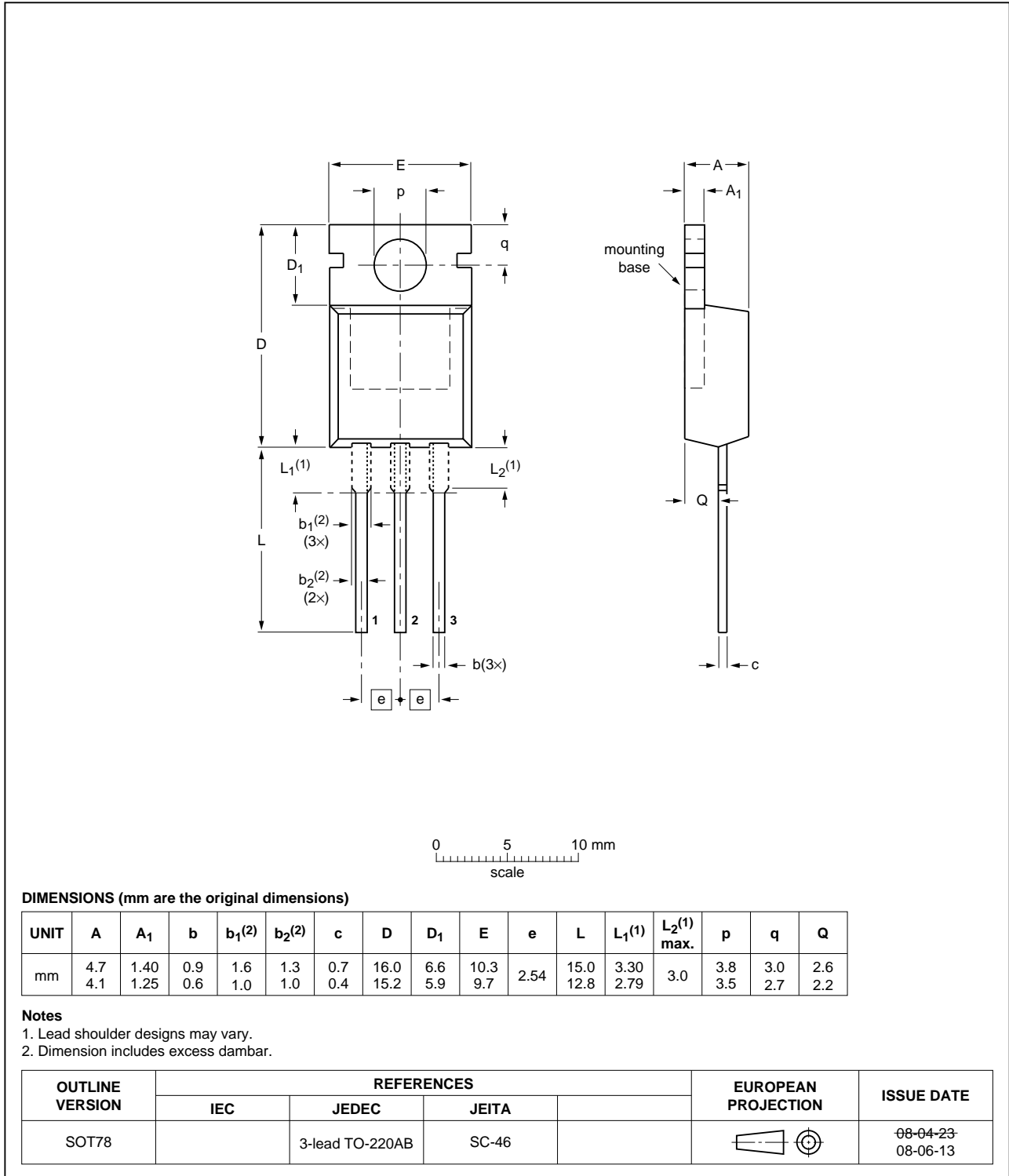


Fig 12. Package outline SOT78 (TO-220AB)
